ORDINANCE NO. 2022-7

AN ORDINANCE TO AMEND ORDINANCE NO. 697(96) OF THE CITY OF ATTALLA ALABAMA PASSED AND ADOPTED _____.

BE IT ORDAINED by the city council of the City of Attalla, Alabama, that ordinance No. 2022-7 as amended, passed and adopted on July 5 2022, and being an ordinance setting and fees and charges for building permits be amended so that same shall hereafter read as follows:

SECTION I. Any person, firm or corporation shall, before commencing the excavation for or the construction of any building or other structure, including accessory structures, or to store building materials or erect temporary field offices, or to commence the moving, alteration, or repair of same, must first obtain from the City of Attalla a building permit and pay the following fees and charges for same, based upon the contract price of improvements:

Total valuation	Fee
\$1,000 or less	No fee, unless inspection required, in which case a \$25.00 for each inspection shall be charged.
\$1,000 to \$50,000	\$25.00 for the first \$1,000.00 plus \$10.00 for each additional thousand or fraction thereof, to and including \$50,000.00
\$50,000 to \$100,000	\$515.00 for the first \$50,000.00 plus \$8.00 for each additional thousand or fraction thereof, to an including \$100,000.00
\$100,000 to \$500,000	\$915.00 for the first \$100,000.00 plus \$6.00 for each additional thousand or fraction thereof, to and include \$500,000.00
\$500,000 and up	\$3,315.00 for the first \$500,000 plus \$4.00 for each additional thousand or fraction thereof.

MOVING FEE

For the moving of any building or structure, the fee shall be \$150.00

DEMOLITION FEE

For the demolition of any building or structures, the fee shall be:

0 up to 100 cu ft.	\$100.00
100,000 cu ft. and over	\$1.50 / 1,000 cu ft.

Penalties

Where work for which a permit is required by this code is started or preceded prior to obtaining said permit, the fee herein shall be doubled, but the payment of such doubled fees shall not relive any persons from fully comply other penalties prescribed herein
